Eligibility:

- Nominee must be in business for at least five years located in the club's Service Area:

Who may nominate a business?

- A member of the community
- A fellow business, or business professional
- A member of West St. Louis County Rotary
- A civic or community leader

What are the criteria for nomination?

- The most important criterion is service to the community.
- The nominee will reflect the spirit of the Rotarian's 4-Way Test in the way they operate their business.

How do you nominate a business or business leader?

1. Complete nomination form
2. Write a letter of recommendation for nomination of the nominee.
3. Include one additional letter of support.
4. Letters of support from other community members are encouraged.

What should be included in the letter of nomination?

Simply state why you feel the business or individual you nominated should be a candidate for the Rotary club of WSLC Community Business Award. It may include how the business or business leader has benefited their local community, their professionalism, their activities in and beyond their business including community involvement, and their ability to inspire by their service to others.
